

CHAIR'S REPORT

Welcome to the 2022 Annual Report of the Icelandic Society of Great Britain.

I am often involved in conversations with members about what the IHSGB does, or should do, and I think it is worth restating our purpose here. This is an abbreviated description - the full version can be read in our Articles of Association on our website.

The IHSGB exists to educate the public about the Icelandic horse and its origins, preservation and standards, and to improve general



standards in the management, use and treatment of horses, with particular reference to the special features of the Icelandic horse.

We have a range of powers to enable us to achieve these objectives and they include (not limited to):

- maintaining and publishing the studbook rules
- arranging assessments of Icelandic horses and riders according to the FEIF rules,
- organising the training of national judges,
- promoting the welfare of the Icelandic horse through membership of FEIF and other appropriate bodies,
- organising shows and other events such as exhibitions and lectures,
- raising funds to support these activities and the objective of the Society

In the early part of 2021/22 the activities by the Society were somewhat constrained by restrictions brought about due to the Covid pandemic, but it is pleasing to see how much was still achieved during this year, through the work of the volunteer trustees and enthusiastic members, who organised and hosted events for the benefit of the wider Icelandic horse community. There is significant work undertaken by Trustees

and other volunteers to support the Society in meeting its objectives and I would like to thank them for their time and commitment.

In February 2022 I was able to attend, along with our then Sport Trustee, Becca Hughes, the FEIF conference held in Norway, where I had the opportunity to meet with the Chairs of Iceland Horse Associations across the world. It was pleasing to see a big focus on the welfare of Icelandic horses at the conference and I am optimistic that we will continue to see developments in the competition rules and guidance that will benefit our horses. During the Chairs' meeting we also dealt with some sensitive issues around conduct of officials, and we will be meeting again shortly (virtually) to discuss this matter further. I should be able to provide more information at the Annual General Meeting.

In my first year as Chair, I had wanted to improve communication with members and to bring a greater focus on promoting the welfare of the Icelandic horse in the UK. At the Board, and in discussion with the Sport Trustee, we put a greater emphasis on the welfare of horses at our Summer Show and British Championships. I prepared more guidance and more detailed judging criteria for the Track and Trail class as part of this initiative, to promote higher standard of riding, and we added a Best Partnership Award for this class to reflect this. We had also intended to hold a series of seminars to help people prepare for competitions, and to further promote horse welfare, but unfortunately we didn't manage to get these in place. We will arrange these for the next year, alongside some more visible guidance on training and welfare at the Show itself. The Society updated its guidance on rider weight and published this on our website.

In the next year I would like to formally establish a Welfare Group, of 6 - 8 volunteers, to support me in taking forward further initiatives to promote the welfare of our horses.

Taking up the role of chair of the Society, having not previously been on the Board, has been a steep learning curve for me personally, and I have not been able to give all the time that I think this role really needs to take the Society forward. I am therefore pleased to say that our former Chair, Peter Heathcote, has agreed to support me, by taking on an ambassador role for the Society from November 2022. Working directly with me as Chair, Peter will use his already established connections to liaise with FEIF, member countries and the Icelandic Embassy to assist me in promoting the aims of the Society.

I still feel we have more to do to improve communication with, and involvement from our membership, and commit to do further work on this in the following year, alongside benchmarking our IHSGB with other UK Breed Societies and small charities around communication, governance and structure to seek ideas for further improvement.

STUDBOOK ANNUAL REPORT

At the time of writing, there are 1045 registered Icelandic horses located in the UK. In terms of country of birth, the population of live horses in the UK is now made up as follows:

A total of 13 foals were born and registered in 2021. The number of foals born in the UK was on an upwards trend over the 2017-2020 period, but the 2020 breeding season appears to have been affected by Covid-19, thereby reducing the foal numbers for 2021. It will be interesting to see how the trend continues over the next few years.

BREEDING TEAM REPORT




Over winter we held our popular webinar "Meet the foals" again, this time with 18 participants on the night. Dísa






Meet the foals 2021
















Otherwise breeding and studbook have been very busy keeping up with ever changing rules and regulations.

YOUTH REPORT

Youth has been relatively quiet this year but I have emailed everyone who has a family membership to clarify and update how many IHSGB youth members we actually have (upto the age of 18*) and where they are! Few and far between but we need to know who they are and what they would like organised! So please contact me!



The FEIF Youth Cup was due to be held this year in Switerland at Solfaxi, an Icelandic Horse Centre about 30 car minutes from Berne. However it was cancelled, again due to Covid. I realise that there are youth members who will not have had the opportunity to partake of this type of competition due to covid and are now too old.

The Dutch youth committee are looking for stories for a Christmas edition of their youth magazine from children owning and caring for Icelandics – including photos – so if any of our youth would like to contribute please contact me.

Hopefully the youth camp will occur in Finland in 2023 and we will let Members know the eligibility criteria when it is available.

The FEIF YouthCamp was the first youth event organised by FEIF. It all started in 1986 when an "international youth week" was arranged by FEIF and the Netherlands. 1988 Germany hosted the newly named FEIF YouthCamp and ever since this camp has run every second year.

The goal of the FEIF YouthCamp is to bring together young people from different countries. All should share a passion for the Icelandic horse, and the participants will also learn something of the horse culture(s) of the host nation.

In order to take part in the FEIF YouthCamp, riders do not have to own (or bring) a horse, but they should be interested in Icelandics, and have some riding experience. Throughout the week a range of activities, with and without horses are offered. These vary greatly, and have in the past included hiking and other outdoor activities, crafts, long hacks, and even polo lessons on Icelandic horses. Participants are expected to join in all activities. The aim of all FEIF youth work is to create an awareness of different (horse) cultures, to raise standards of all aspects of horsemanship, and to foster international friendship.

The IHSGB youth awards are ongoing this year along with the leisure awards so please tally up all the events and activities you have done for these

FEIF Youth Country of the Year 2021

After two years of the restrictions the pandemic inflicted on so many horse activities within the FEIF member countries, the judges decided to make the award less on what had actually been organised, but rather pay more attention on the obstacles faced by 'small countries' in terms of Icelandic horses.

In their report, the Youth Committee of Great Britain provided a realistic and honest analysis of the difficulties they face in terms of low numbers, a small budget and huge distances between young riders. At the same time, this was balanced by the innovative ideas that could be implemented and the lessons learnt from the isolation caused by living with Covid 19.

REPORT OF THE SPORT GROUP

Let me take this opportunity to say 'hello' as the new Sport Leader and 'thank you' to Becca Hughes for her service in the role over the last nine months. I'm happy to say that Becca is remaining as part of the Sport Group team, and also Fi Pugh has joined us as a full member.

It's been a busy year for the group and we're gearing up for an even busier one as we look ahead to the World Championships (WCs) in the Netherlands in 2023.

After many months of planning and meetings, the British Championships took place once again this June. Hosted at the



fabulous Aston-le-Walls Equestrian Centre, we had 36 combinations entering a whole range of events covering oval track, pace track, and track and trail. In a first for the BCs, we were excited to offer a live-stream of selected events on Facebook, which I know was well received. We apologise for the lack of rosettes, but they WILL be sent out soon (if not already).

Late August witnessed the inaugural 'Scottish Open' competition, an event the IHSGB was proud to support with a £500 grant. The show was a great success, and many congratulations go to all involved in making it happen.

Warm congratulations also go to Mike Adams, Jemimah Adams, and Nadine Kunkel for representing GB so well at the MEM in Germany recently. It's no small effort to get horses abroad these days and to then go on and perform at a high level is just fantastic.

Following changes in the Team GB selection criteria, we were thrilled to designate the IHSGB Oval Track Competition at Connegar Farm on 8/9 October 2022 as a national team qualifier. Previously we only ever held one qualifying event in the UK per WC year, but hopefully now we will be able to take more opportunities to stage qualifiers in the UK for our home-based riders. Speaking of which, anyone hoping to qualify for the WC team should kindly refer to the new Sport Team Selection Criteria for 2023 and register their interest with me by 15th January 2023.

This year has seen another two-year judge training program run its course, with three

IHSGB members passing the theoretical section of the regional sport judges examination. These will candidates be hoping complete the final practical section at the IHSGB October competition. Qualified and trainee judges will then have the opportunity to continue their learning in 2023 with further webinars and video exercises.

Finally, the Sport Group will soon be issuing a Participation and Feedback survey. This will be your chance to tell us what Icelandic Horse Sport means to you and help shape the format of future competitions and events in the UK.

FINANCE REPORT

The 2021/22 Financial Year ended with the Society's income almost matching its' expenditure – generating just a small surplus of £430. So how did we get there, what were the key variables and points of note and what does this mean for the future?

As previously discussed, and highlighted again in the Bursary Scheme (detail overleaf), we know that activity throughout the Society has dipped in recent years compared to the pre-Covid era. The result was that that we spent less, plans were cancelled and our reserves built up. Whilst holding investments and reserves gives the Society the flexibility to have good and not so good years there needs to be a robust argument to support this instead of spending such monies on the charitable cause. Furthermore these reserves should not be disproportionate in size to the Society's day to day activities.

With this in mind the IHSGB Bursary Scheme was born and, at the time of writing, approximately 10% of our membership have taken advantage of it and received grants. In the 2021/22 financial year, remembering that the scheme only went live in June 2022, £1,400 was paid out in bursaries. Articles are now trickling in from members telling us what they did with their grants - read more in the Christmas edition of Sleipnir.

In 2021/22 we also supported the inaugural Scottish Open Show with a grant of £500 and invested £1,000 in the Society's own annual show and festival, the British Championships.

Yet despite all this munificence we ended the year with a small surplus and our reserves intact! If we tunnel down into the accounts further we see that once again significant donations were made from generous members. Over £1,300 was donated in support of the Festival/British Championships and a further £495 to defray some of the costs of getting two Trustees to the annual FEIF conference. More of you made smaller donations and, of course, every time you participate in the IHSGB lottery or have signed up to Amazon Smile, the Society also benefits. Thank you.

Thanks to our loyal membership our income streams remain robust and we can move into 2022/23 with plans intact. We are currently revisiting our three year rolling budgets, ensuring the Education initiative continues and that finances exist to support

and underpin both the Festival and Summer Championships and the new and innovative program put together by the Breeding Team. We will continue to subsidize events for our members and bring in an exciting range of international trainer talent as well as our home grown experts! We are also growing our local resilience as the Judge Training Programme continues; modules 2 & 3 of the 2nd full course ran during 2022/23 and 4 participants are through to the final examination process this Autumn. A total of 14 members completed all three modules adding to their knowledge of the Icelandic horse and enabling them to act as trainee judges when required.

The Society's commitment to FEIF endures and, as above, our participation on the national stage was again supported by a generous donation. This donation tops up the funds the Society itself invests into FEIF.

Of note:

- We received >£2k of donations in year to help us reach our Income & Expenditure position of a £430 surplus
- Membership income remained relatively stable. Subscriptions totalled £8,842.
 (£9,300 in 2020/21)
- Gift Aid has been estimated and is accrued for (ie: we expect HMRC to pay us £1,450). 141 memberships (out of 243) are signed up for Gift Aid
- We awarded £1,400 in IHSGB bursaries
- We donated £500 to the Scottish Open
- Studbook made a small surplus of £193
- The winter breeding seminars cost £321
- Sport the BC's made a loss before member donation(s) and Society funds of £2,332
- Our investments lost money in year but the interest on these funds just about balanced out the loss. Our investments are held with CAF – the Charities Aid Foundation. Interest received £647 v. a loss in fund value of £707, net position -£60
- There was no activity recorded under Youth or Leisure
- Education ran one course with 10 participants. The IHSGB subsidy for this course was £544.
- The IHSGB Lottery made a net £473 with an average of only 14 players.

• Judge training ran two modules and incurred some set up expenditure for the exams in August and October 2022. Net position -£296.

As always thank you to the members who have paid their 2022/23 subscriptions – subs become due on the 1st August each year. After that our Membership Secretary, 'H', will send you a series of reminders until October 31st when all member benefits will be lost and membership will lapse. We don't want to lose you but, if we have to, then please let us know why and how we could have retained your membership. Chat with Catherine, our Chair (chair@ihsgb.co.uk) and provide that feedback loop as our ongoing challenge is to grow our membership and then retain you all as members. Paying your membership gets ever easier as our website allows you to complete membership forms online or renew and update your details with simple links to Paypal or reminders of alternative ways to pay.

We are able to claim Gift Aid on your membership subscriptions if you have signed up to the scheme with us. The Society's income increases by £9 and £11.25 on each gift aided single and family membership respectively.

For information; Gift Aid is a tax relief allowing UK charities to reclaim an extra 25% in tax on every eligible donation made by a UK taxpayer. The IHSGB is a registered charity so we can claim an extra 25p for every £1 you give and it doesn't cost you any extra! This year we have been able to claim £1.45k from HMRC Thank you.



A reminder too about the IHSGB Development Fund: the interest earned each year from the Development Fund can be used to award grants that will further the Society's objectives. Applications should include the reasoning why the applicant believes that the Society objectives would be enhanced and state the benefits to be gained. There is an application form on the website or <a href="mailto:ma

THE IHSGB Training Bursary

Background

The last few years have seen only a fraction of the activity we would normally hope to deliver. Because we have not been able to offer as many of these day to day activities as planned we introduced a new initiative for Members in 2021/22, offering a one off £50 training bursary to all Adult Single Members of the Society and a £62.50 bursary per Family Membership (the pro rata equivalent of your annual £36 single v. £45 family Membership fees).

Eligibility

The ONLY mandatory eligibility criteria for receiving this bursary is that, on application, you must be, and have been, a fully paid up Member of the Society for at least three consecutive years.

The bursary will be paid directly to you, the Member, and the Society requires no subsequent 'proof' of spend/usage. All we ask is that the money is used in the spirit of the award, the grant being made to fund activities that will, broadly, further the Society's objectives. Indeed, as a Charity, this is a must do/have!

We do request that you subsequently write a short account of how you used the money. These summary articles will be collated and shared, anonymously, in future editions of Sleipnir – just to show the range of activities and opportunities out there for Icey owners. Maybe you want to use the money to help pay for a course fee, attend a series of webinars, travel to an Icelandic event, facilitate organizing an event etc. etc?....there is no blueprint: this is a 'payback' to Members for them to use as they see fit with their Icelandics and to help with costs.

THE SOCIETY'S **OBJECTIVES**

To educate the public about the Icelandic horse and its origins, preservation and standards in accordance with the standards of FEIF (The Federation of Icelandic Horse Associations).

To improve general standards in the management, use and treatment of horses with particular reference to the special features of the Icelandic horse by the education of breeders, importers, owners, judges, veterinarians, trainers & Members of the public.

The Future

We estimate that if 100% of our Members were to apply for this bursary then that would reduce the Society's reserves by c. £12,000. We cannot estimate take-up but feel it is unlikely that all Members will

take advantage of this initiative. Each Membership (Adult or Family) can only apply once and this bursary program will remain open for three years, with a spend cap of £4,000 in each financial year.

Obviously using Society funds (ie: spending some of our savings) in this way will reduce our ability to grow any education program, or fund other initiatives, over and above the monies we have available to us in any one financial year. However we do feel that our reserves have, through exceptional Pandemic circumstances, grown inappropriately and we would like to make this offer to our Members before we can, once again, offer more activities in year as the 'world opens up'!

Live Now, year two of three!

- Applicants must be a current member of the Society and have been a member for THREE consecutive years at the time of application. If the category of membership has changed during that time, for example youngsters covered by a family membership have now become single members, just the Family bursary will apply until the young members have achieved 3 consecutive years of single membership.
- To apply, please fill in the IHSGB BURSARY APPLICATION FORM available online through the Members Area of the website.
- Bursaries will be awarded in year in the order of date of application until the spend cap is reached when o/s applications will be carried forward to the following year. If an application is carried forward the revised application date will be the 1st August of the new financial year ie: the three year consecutive membership eligibility criteria will be judged as at 1st August.

THE SCHEME

The Bursary will run for three financial years, 2021/22, 2022/23 and 2023/4.

However the Board reserves the right to bring the scheme to a close at any point dependent on the financial positon of the Society in year.

An initial spend cap of £4,000 will exist for each financial year but this will be kept under review.

2021-22 has been rather quieter for Education than previous years, perhaps due to Covid and people changing their routines, as well as rising costs and travel uncertainties.




IHSGB TOLT ONLINE

IHSGB Tolt Online continues to be an excellent tool for IHSGB members, and we have had a few entries since the last AGM report. Being online, it means that riders of all abilities are able to ride a test of their choice and receive feedback and a score from an internationally qualified Icelandic Horse judge and trainer. We hope that this platform continues to help riders train themselves and their horses from afar.

IHSGB EDUCATION HUB

The IHSGB has not been able to organise as many courses as we would have liked, partly due to travel being uncertain and trainers being busy, or a lack of organisers in available locations. I reiterate that it is up to you if you'd like to host an IHSGB course in your area, I can help make it happen but I need you to help me with new or tried and tested locations, especially if you don't feel you have the opportunities to attend an IHSGB education course or you feel they have always been at the same locations.



Most IHSGB courses in the past have been oversubscribed and waiting lists made, so it is evident that these courses are well received. We have been able to hold a course with Baldvin Ari Gudlaugsson in Wales by kind invitation of Peter and Katherine Heathcote, in September 2022 and we intend to organise more courses going into the next membership year of 2022-23, which all riders are welcome to attend.

Don't forget you can also apply for a grant to help towards costs of member-run events. We need active people to make things happen in more areas!



IHSGB TRAINING AND EDUCATION SYSTEMS

As you may know, after 6 months of preparation, the Young Rider Badges were released in 2020 with one Young Rider in the UK passing the Level 2 badge within a month of the release. There has been interest in 2022 from a couple of youth riders, and we currently wait for their entries to be assessed, good luck!




