CHAIR'S REPORT

This year saw the election of new Trustees to the Board, and a lot of work in the background to update policies and procedures and develop new initiatives. Much of this work is ongoing, and I am grateful for the enthusiasm and hard work of the Trustees and Management Team, who give a lot of time and thought to the Society. Earlier in the year we began a review of how the Society is managed and governed. We have struggled to find a suitable time that we could all get together to collate and discuss the themes we identified, but will be doing so the day after the AGM, where we will also have the feedback from the members survey that is currently being conducted.

We greatly increased the number of demonstrations we did, where the Icelandic Horse, its gaits and nature, attracted a lot of attention. A number of people sought us out at subsequent events, keen to pursue conversations about Icelandic horses and how and where to buy one! I am convinced that such events, alongside members getting 'out there' with their horses, are an important part of achieving one of our aims - to promote the Icelandic horse, and also increasing awareness of the Society. The results may take time to materialise, but there's no doubt that we create an impression wherever we go. Those that ride in, and support such events put in a lot of time and effort, and I thank all involved. Many of the invitations to ride at these events have come from personal contacts in someone's local area. If you are able to help with an event in your area, please do get in touch.

THE SOCIETY'S OBJECTIVES ***

To educate the public about the Icelandic horse and its origins, preservation and standards in accordance with the standards of FEIF (The Federation of Icelandic Horse Associations).

To improve general standards in the management, use and treatment of horses with particular reference to the special features of the Icelandic horse by the education of breeders, importers, owners, judges, veterinarians, trainers & members of the public.

It was a memorable year for our British Championships and Summer Show, with the attendance of Princess Anne, but also a number of new and youth riders joining our ranks, and the introduction of a virtual element of the show enabling more members to be directly involved.





Our first Breeding Show in Wales was held at an excellent venue in South Wales, utilising a Trotting Track, which got me thinking (and googling) about other similar venues and the possibility of building stronger relationships with other equine disciplines with facilities that might suit our needs. Perhaps you know of somewhere?

We were delighted to support the Scottish Open once again, both financially and practically, and really appreciate the hard work of the organisers of this event. The Society will continue to support the Scottish Open, and hopes that events will flourish in other areas in the future.

We have now established a Welfare Group, agreed a Terms of Reference and met a few times to discuss areas where we can make an impact and provide more information for members. We have not met as often as I would have liked, and it would be good for us to be able to put some more time into this next year. There is one vacancy on the Welfare Group, so let us know if you are interested in joining.

In previous years Trustees and Management Team members have often had to cover several roles at once. This year we were closer to a full complement, and it really makes a difference the more volunteers we have to get through all the work and bounce ideas around. We advertise vacancies and requests for volunteers on the website. Please get in touch if you think

you can help.

I had hoped to complete the third year as Chairperson, but changes in my family circumstances mean I need to stand down at this AGM. I will support the new Chairperson in picking up the Review process we started this year, and plan to continue to be involved in supporting the Society in some capacity as soon as I am able.

STUDBOOK ANNUAL REPORT



At the time of writing, there are 1046 registered Icelandic horses located in the UK.

In terms of country of birth, the population of live horses in the UK is now made up as follows (in the table overleaf):

A total of 10 foals were born and registered in 2022. The number of foals born in the UK was on an upwards trend over the 2017-2020 period, but the 2020 and 2021 breeding seasons may have been affected by Covid-19, reducing the foal numbers for 2021 and 2022. Judging by the number of reported servings, the numbers may well be going up again in 2023.

BREEDING TEAM REPORT

The last year was a busy one... We invited Elisabeth Jansen, a lecturer at Holar University/Iceland, FEIF Sports and Breeding judge, to be our partner for the activities during the year.



We started with a WEBINAR in October, looking at the upbringing of horses and their development, as well as how conformation affects the riding ability of a horse in a positive and negative way.

This was followed by a YOUNG HORSE ASSESSMENT in 2 places, Wales and Somerset. A total of 22 young horses were assessed during a 2 day period.



In April this year, we held a COMPETITION/ASSESSMENT WEEKEND on a Welsh trotting track close to Ammanford. The track was a real find, as the surface was perfect for riding all the gaits. Elisabeth judged one mare for conformation,



explaining the judging and measuring process along the way, which was very interesting for people to watch.

We held our competition over two days, with individual lessons on offer as well.

SO WHAT IS IN THE PIPELINE FOR THE 2023/2024 YEAR?

Most probably another one or two webinars, possibly a young horse assessment and a combined competition/breeding show weekend. One big request to you all – after having seen how nice the Amman Valley trotting track was to ride on, I've also started to look for Speedway tracks around the country.

If you are aware of a trotting/Speedway or any track/venue close to you that might be suitable

for a competition weekend, please get in touch with me...it would be great to offer activities in other parts of the UK as well. Having a weekend with something on offer to everyone, is great fun and so educational at the same time.



So get your thinking caps on – we need your help in finding possible tracks to plan activities in other regions, too.

What a fantastic year we have had for Youth!


I put to the trustees that we should come in line with FEIF age brackets so the IHSGB will recognise a Youth member up to the age of 21, so that means that although you will be paying adult

- Volunteers
- IHSGB event or competition organiser
- All members

This is to ensure that we keep our youth members safe and equip all others with relevant and up to date information.

The young rider badges are still available to take part in, I did mention in an edition of Sleipnir that I was updating these, I am still in the process of this as the end product will be a workbook for those taking part in the badges. If you have images of your Icelandic that you would like included in this, please send them to me with your name, your horses name, and the year the picture was taken. This is open to all members.

There is also a newly published FEIF Youth Cup Selection Criteria, the 2024 youth cup will be held in Switzerland.

The focus of the Youth Cup is on teamwork, sportsmanship and improving riding skills. Riders are aged between 14 and 17 with the aim of fostering friendship and an awareness of cultural difference. It consists of a week of intense training with respected instructors of international standing. At the end of the week there is a competition held that has of range classes. At all international FEIF events English is spoken. Rental horses are available as the costs and paperwork involved with traveling now the UK has left the EU can be overwhelming.

I am in the process of discussing and designing badges for youth members and the elder youth, this will include the young rider badge levels, hopefully this will go ahead in the new year.

I will be working closely with the leisure trustee to come up with some joint events to include youth members. Some of these maybe online and we are hoping to organise

a face-to-face event. When organising a face-to-face event, it does bring about some challenges, the main ones being distance and venue. If you have any suggestions of venues that you feel would be able to accommodate us, please do reach out.

Many of you would have seen various flyer type posts across our media platforms, I have been involved with the production of these as well as the before mentioned youth welcome pack. I am hoping by the time this has been sent to all members the new membership pack will be available that I have been working on. I am also in the process of updating the current leaflets and literature that is given out to the public to hopefully give a more up to date feel. There may also be a guide to competition sitting in another file on my computer waiting to be finished and brought to the other trustees for approval, that may be ready for Spring 2024!

This year our British Championships at Aston le Walls was a triumph for the Sport Team led by Torben Rees, our Ambassador Peter Heathcote and Chair Catherine Holland with HRH Princess Anne in attendance. Its testament to all their hard work (plus all the other trustees, members and other volunteers that pitched in) that not only did the classes run well and smoothly but HRH had such a good time she would like to return. Martine and I worked hard to achieve some great sponsorship this year, one of my contacts Radnor Hills providing a vast amount of liquid refreshments right at the last minute which due to the heat was massively appreciated. Martine brought in some impressive cash donations that paid for prizes, rosettes both online and live. I secured sponsonship for prizes, gifts and goody bag treats for riders and helpers, not an easy task as most companies had their budget set the year before. Just before the British Championships I engaged my very busy daughter (studying for finals at her Exeter University) Millie Wogan to breathe life into our rather unused Instagram with astonishing results, 500% we've had а

increase in interactions and our team GB video receiving 1500 plays an impressive increase with 90% of that reaching non followers. While at the world championships we had a follower increase of at least 2 per day. The account has increased from 196 followers in April to 327 by October. On the private Members Forum FB page we're communicating with our members with 300% increase in the last year. Meanwhile our regular e-bulletins keep those of you not on social media up to date.

IHSGB selected a great team of riders to represent us at the World Championships in the Netherlands. 7 adult and 1 youth rider were selected. 7 chose to represent GB (at great personal expense). Of these 7 horses 4 were owned, trained or ridden by Mike, Elizabeth and Jemimah Adams what an achievement with 3 combinations only been paired with their respective rides for a few months or weeks. A new team kit was chosen by the riders from Tylers at squad training in April and for the first time was on sale for supporters as well as riders. We are all extremely proud of our riders and horses with the lack of competitions and training in the UK and the costs prohibitive to European competitions they had a great team result of 10th and a personal best speed from Mike and Rut in only their 2nd competition.

We are able to claim Gift Aid on your membership subscriptions if you have signed up to the scheme with us. The Society's income increases by £9 and £11.25 on each gift aided single and family membership respectively.

For information; Gift Aid is a tax relief allowing UK charities to reclaim an extra 25% in tax on every eligible donation made by a UK taxpayer. The IHSGB is a registered charity so we can claim an extra 25p for every £1 you give and it doesn't cost you any extra! This year we have been able to claim £1.43k from HMRC Thank you.



Our Ambassador's Report

I was appointed as ambassador to the IHSGB in late 2022 to focus on some key objectives on behalf of the board. Initially my work was ensuring the relationship we had started with the Icelandic embassy in London whilst I was chairperson was nurtured and then engaging with the Palace to establish the possibility of a Royal Visit to the British Championships by HRHThe Princess Royal.



Receiving the confirmation in January that HRH The Princess Royal had accepted our invitation was an incredible feeling. The following 5



months involved a huge amount of work, several hours of site visits, many, many telephone calls and zoom meetings. In the end the day was a huge success, thank you to everyone who made it all possible and took part on the day, a special thanks to all those who spent many hours working though draft itineraries and possible options. I would like to thank the board for trusting me to deliver this project on behalf of the Society.

My friend Mubarak Ali invited me to an event at the Mosque in Newport in his role as secretary for the Islamic Society for Wales based in Newport. At this event I met various dignitaries and was asked by HM Lord Lieutenant

of Gwent Brigadier Robert Aitken CBE if I would invite him to meet some Icelandic horses at my home. This in turn resulted in an invitation for the society to carry out displays at the Monmouth and Usk agricultural events. I personally attended the Machen and Monmouth displays and rode Svali from Tockholes. All three of these events were well attended and supported by incredible teams of enthusiastic IHSGB volunteers from ground crew to riders, thank you to



them all. I then attended the All Steps event as ground crew on the Friday and had a fantastic time. This event was very popular and the IHSGB riders and support were superb.

After riding Icelandic horses as a guest in Transylvania last October organised by Far & Ride (who Offer IHSGB members a discount) I negotiated a members discount with the owner, we talked about the family of FEIF and how important it is. At the end of the holiday Andras informed me he had written to FEIF regarding the membership process. On returning this September I was delighted to hear that România are scheduled to be voted in as members of FEIF at the delegates'

assembly 2024. I felt very proud to have played a small part in this as ambassador. At the IHSGB education event in September I invited HM lord Lieutenant of Gwent, the Ambassador of Iceland, the mayor of Caerphilly and some distinguished guests to meet the Icelandic horse and rider combinations along with Baldvin Ari Gudlaugsson the trainer. The event went very well and I was delighted to receive a gift from the Prime Minister of Iceland presented by the Ambassador of Iceland.

FINANCE REPORT

The 2022/23 Financial Year ended with the Society making a small loss, much less than was planned! Remember we were aiming to spend more than we received in income in 2022/23 as we built up reserves during the Covid years and were trying to get these monies back out to our membership. However you seem loath to apply for the Bursary scheme and we can only help facilitate with events and training courses if members step up and forward to host and/or help. Our loss was £1,466 meaning our balance sheet reduces by the same amount - the Society is worth £1,466 less than it was this time last year.

So, once again, how did we get there, what were the key variables and points of note and what does this mean for the future?

As previously discussed we know that activity throughout the Society dipped in the Covid years and, actually, hasn't fully recovered as the cost of living crisis impacts on members' activities. We spent less, plans were cancelled and our reserves built up. Whilst holding investments and reserves gives the Society some year on year flexibility there needs to be a robust argument to support this instead of spending such monies on the charitable cause.

In addition to our drive on Education, with the IHSGB subsidizing the cost of courses using home grown and imported FEIF trainers, the IHSGB Bursary Scheme was born with grants available to all members¹ to help with the costs of training with their Icelandic horses.

Grants are also available to help with the costs of Member hosted events...but things remain quiet, the last event grant applied for was some 2 years ago and even the interest in the Education courses seems low...a few years ago many of us were scrambling to get a place on these courses! Interest earned by The IHSGB Development Fund is used to award these grants - targeted at events and/or training that will further the Society's objectives. As well as the smaller grants on offer the IHSGB was again delighted to be able to offer support for the 2^{nd} Scottish Open Show with a grant of £500. Help with clothing costs and training costs were offered to those on our World Cup Squad and the Society invested a further invested £2k in our own British Championships.

We could have made a greater loss (a bizarre position for the Treasurer to be targeting) but for the valiant efforts of our Trustees, well Martine actually, sourcing sponsorship for the Summer Festival/British Championships. She secured $\pounds_{2,750}$ in a very short space of time!

If we tunnel further down into the accounts we see that, once again, significant donations were made from generous members. Over £1,060 was donated in support of the Festival/British Championships and a further £495 to again defray some of the costs of getting two Trustees to the annual FEIF conference. More of you made smaller donations and, of course, every time you participate in the IHSGB lottery the Society also benefits. The lottery made us £430 this year...with just a handful of players! If you are tempted to gamble for a good cause then please join the IHSGB Lottery! O The payouts aren't huge but there's always the expectation they might be! Thank you.

Our Breeding Leader delivered a new programme this year - a series of webinars offered free of charge to all members, a young horse assessment across sites and a Breeding Show and fun sports show....attendance was again, niche, but those that went had a whale of a time and recommend more to try it! Yes it was south of the great north-south divide but find the venue and the demand and I am sure Ellen would be very keen to chat!

Our income streams from Members' subscriptions remain robust but we continue to lose about the same number of members that we gain each year. Elsewhere in this report and at our AGM we will be exploring further just what you expect of the Society but with a reminder that we are a Breed Society and not a Riding Club! It has to be us, the members, who make things happen over and above delivering our Society's objectives.

Four more Regional judges qualified in October 2022 having completed the Judge Training Course run by Fi Pugh. More judges are therefore available for members to call on to help at their own events!





The Society's commitment to FEIF endures and, as above, our participation on the national stage was again supported by a generous donation. This donation tops up the funds the Society itself invests into FEIF. We would like to send three delegates to conference in 2024 but can probably only justify the cost for two. Hopefully FEIF will also start to look at more use of virtual platforms in the future too.

Of note:

- We received >£2k of donations in year
- We received £2,750 of sponsorship for the British Championships and the World Cup Team Members also received personal sponsorship packages to help with their costs.
- Membership income remained relatively stable. Subscriptions totalled £9,273 (£8,842 in 2021/22)
- Since year end Gift Aid claims have been submitted to HMRC for the 2021/22 and the 2022/23 financial years. These have added £2,860 to the coffers.
- We awarded £1,237 in IHSGB bursaries (total awarded over the 2 years of the scheme is £2,637)
- We donated £500 to the Scottish Open
- Studbook made a surplus of £1,040, supply costs have dropped quite dramatically over and above the lower costs passed onto our members
- The Breeding & Fun Shows made a loss, ie: we invested in them, of c. £1.8k
- Sport the BC's made a loss, ie: we invested in them, of £2k
- Our investments are held with CAF the Charities Aid Foundation. Interest received £876 and a small loss in fund value of £83, net position £793
- Education ran one subsidised course with 10 participants.
- The IHSGB Lottery made a net £430.
- It cost a net £296 to qualify 4 new Regional judges in October 2023.

As always thank you to the members who have paid their 2023/24 subscriptions – subs become due on the 1st August each year. After that our Membership Secretary, 'H', will have sent you a series of reminders until October 31st when all member benefits will be lost and membership will lapse. We don't want to lose you but, if we have to, then please let us know why and how we could have retained your membership. Chat with Catherine, our Chair (<u>chair@ihsgb.co.uk</u>) and provide that feedback loop. Paying your membership gets ever easier as our

website allows you to complete membership forms online or renew and update your details with simple links to Paypal or reminders of alternative ways to pay.

IHSGB TOLT ONLINE

IHSGB Tolt Online continues to be an excellent but IHSGB Tolt Online continues to be an excellent but rather underutilised tool for IHSGB members (and non-members). We have had 8 entries in the last **EDUCATION** membership year. Being online, it means that riders





of all abilities can ride a test of their choice and receive feedback and a score from an internationally qualified Icelandic Horse judge and trainer on their gaits. We hope that this platform continues to help riders train themselves and their horses from afar.



IHSGB EDUCATION HUB

Education in 2022-23 has been very much like the previous year; it continues to be difficult to find willing volunteers and therefore venues to organise courses with the IHSGB, so the IHSGB has not been able to organise as many courses as we would have liked.



We held a course with Baldvin Ari Gudlaugsson in Wales by kind invitation of Peter and Katherine Heathcote, in September 2022 which was as successful as always and therefore Baddi has just visited Wales again for another successful course (which falls in the current membership year). Additionally, there was a course with Johan Haggberg at Connegar Farm in October 2023, which proved very successful. Most IHSGB courses in the past have been oversubscribed and waiting lists made, so it is evident that these courses are well received.

I reiterate that it is up to you if you'd like to help organise or host an IHSGB course in



your area, I can help make it happen but I need you to help me with new or tried and tested locations, especially if you feel you don't have the opportunities to attend an IHSGB education course or you feel they have always been at the same locations. LEISURE REPORT IHSGB
