5. Sport – FP

Update- British Championships

We currently have twenty nine horses entered, but decisions for tests will come at a later date.

We already have Carina Heller (Germany) FEIF International Sport Judge & Isabelle Mertens (Belgium) National Sport Judge. Sandy Carson will also be returning to the UK to judge for the weekend.

FP had also invited our Regional Judges to co judge/write for the judges.

FP to speak with Kirsty Carson to finalise BC arrangements. Accommodation for judges was in process.

The system used before covid for people to volunteer during the BC's has not proved successful. This is why it was not added to the entry form this year.

Luan Crawford will be helping Ian Pugh with the scoring/Icetest in the secretary's hut.

FP said that she knew what volunteer roles she needed to fill for the sports part of the BC's.

MBD explained that with the introduction of an IHSGB gazebo, merchandise and more a coordinated approach for volunteers was needed.

FP asked about subsistence for the Judges & sport's team.

It was agreed that the three Judges, the sport's team (Kirsty Carson, Crisse Edwards, Robyn Philpott, Andrew Nickalls) & the admin team (Ian Pugh & Luan Crawford) would all have their meals paid for by the IHSGB.

A discussion around spectator's entry fees ensued, as DE has only had a few people pay to visit. This has not been clarified in the past, who pays to attend and who doesn't. As it was too close to this year's British Championships it was too late for any corrections. MBD was concerned that this did not have clarity. FP said in the past, she had not checked this.

Track & Trail, FP will be speaking to Catherine Holland but was not sure of her personal situation. FP will speak to Caherine to confirm her position. MBD suggested that Rebekah Spowage might be able to step in as she is a TREC person. FP will confirm and sort out the Track and Trail class.

8. Breeding & Studbook – Ellen

EB said it would be nice to have The Scottish Breeding Show every year and with a moving venue. Voting on the location was very well accepted by potential participants as they felt involved. The format of education, breeding & competition. It started with riding lessons where you could ride your test. This was followed by the conformation judging by Tom. He explained why you should look at the conformation of the horse.

FG explained that Tom made the whole process relaxed & with humour. This has given people the confidence to say 'next time they would have their horse assessed'.

EB explained that there were lots of very positive comments received about taking this event North. EB also said in terms of logistics it is more difficult. Not knowing the venue, the riders or the riders abilities can be an issue. Two riders did unceremoniously dismount. Both riders were OK. EB & FG had discussed the riders as both were wearing air vests. This may be an indication of their confidence level and perhaps we could keep 'an eye out' for the less confident riders.

EB stated care needs to be taken with doing too many events as we may spread ourselves too thinly. MBD agreed and explained this is why we need a planning meeting to find our way forward.

MBD thanked FG & EB for all their efforts in making this a successful event.

EB would like to organise an event such as this every calendar year and a young horse assessment every two years. The latter being easy to set up, the unfortunate part is the long distance travelling.
