CHAIR'S REPORT

It has been a privilege to carry out the role of Chair for the Society, this year.

The year has continued to be a whirlwind, carrying out the role of Chair whilst also being the lead for Leisure.

At the start of our year (Nov 24) the trustees and management team welcomed two new trustees to the board. Christmas is just around the corner after an AGM, whilst our new trustees 'came up to speed', two other trustees and myself started to prepare for the FEIF Annual Delegates' Assembly (online), followed by a conference in Vienna, Austria, at the end of January. Attending the conference is a very important aspect of our roles. We have an opportunity to build relationships across the world. We discuss issues that are similar, share ideas and potential solutions to problems we might face.

A few weeks later in February the board and the management team met for a planning day. All board members and the management team worked tirelessly to plan for the immediate future of the society. During the year this development has continued with meetings to support our forward planning for the development of the society. New initiatives must be continuous to support the future survival of our evolving Society.

Our Leisure activities have not just been virtual, with a Spring Fun Camp (May 25) and meeting up at the National Equine show (March 25). We've seen online competitions developed by other trustees to support leisure activities this year.

There has been some participation in demonstrations this year. The events have been the Monmouth Show and Kelmscott Manor. One of our aims is to promote the Icelandic horse. This also creates an increased awareness of the Society.

THE SOCIETY'S OBJECTIVES

To educate the public about the Icelandic horse and its origins, preservation and standards in accordance with the standards of FEIF (The Federation of Icelandic Horse Associations).

To improve general standards in the management, use and treatment of horses with particular reference to the special features of the Icelandic horse by the education of breeders, importers, owners, judges, veterinarians, trainers & members of the public.



There is no doubt that we create an impression wherever we go. The riders and supporters of such events put in a lot of time and effort. I would like to thank everyone involved.

Our Breeding Shows and Educational events continue to be well received and supported by members. It takes a lot of time and effort to arrange courses, find venues and have a successful outcome. Members registering for events and remunerations to be collected and invoices to be paid all fill the time of the trustees and management team.

Our British Championships went ahead smoothly in June, with slight timetable changes adapting to the high daytime temperatures. Nevertheless, everyone attending had an enjoyable event. Especially as this has been a World Championship year, riders are aiming high for a place on the GB Team.

The Sport's committee worked extremely hard to ensure the smooth running of this event. The stalls definitely bring another dimension to this showcase event.

By providing members with regular updates, through emails and our website, everyone has remained informed. Communication and dissemination of information is paramount. This is a constant variable within today's world, too much or too little, a balancing act for our communications trustee. Our social media platforms are also used by many members to share events and ideas.

In August, I attended the World Championships in Switzerland. This is always an amazing event. I had a few meetings during the week. I also had the honour of presenting the FI Youth Five Gait World Champion Trophy. It's so nice to be a lone traveller knowing that you are attending an event, where you will not be alone.

Also in August, I attended the Scottish Open event. We were delighted to support this, both financially with a grant and practically. We really appreciate the hard work of the organisers. I have regularly attended meetings with the organisers to support their ideas. This event has flourished and is now growing stronger.

The Youth of our Society are continually given opportunities to join in activities. Sadly we do not have a large number of youth members. There is no easy route to resolve this. If you do have any ideas, please let us know.

The IHSGB Welfare Group continues to meet regularly to discuss current topics and developments. They have been discussing how to provide more information for members on various related topics. Action, plans, or solution intended to achieve a



successful outcome or to move forward. I thank them for their participation and enthusiasm.

There is a FEIF Welfare group now, with representatives from each country and the FEIF groups for sport, leisure etc. Regular meetings are held, topical points are discussed. Situations in various countries are raised and supported with ideas of guidance, support and inspiration.

The Society continues to be a 'full member body" of The Showing Council (TSC). Regular meetings are held online, with the AGM in person. An advantage of belonging to TSC is often the up to date changes (if any) in UK Law, equine infectious diseases and rider safety. Social Licence and The Charter for the Horse are also "hot topics' for the Showing Council. Securing and maintaining social licence is considered essential for the ongoing success and harmonious development of showing, as well as other equestrian disciplines. In recognition of this, The Charter for the Horse was adopted by the BEF and its members, (2024).

"The Charter for the Horse" was developed with BEF stakeholder groups. The Charter encompasses the essence of the <u>FEI Equestrian Charter</u>, composed by the Fédération Équestre Internationale's (FEI) independent <u>Equine Ethics and Wellbeing Commission</u> (EEWC). This edition covers international equestrian sport, while the British Equestrian version is there for all in this country who interact with horses, at every level and in any activity for sport, hobby or leisure.

If you have participated in any activity; local, online or in person I hope you enjoyed it. I must thank you, without your willing participation we would not have a Society.

BREEDING TEAM REPORT



Whilst "normal" years see us organising activities like the **Young Horse Assessment** or a **Breeding weekend** with conformation judgements, tuition and a small competition, this year has required us to focus mainly on breeding compliance jobs.

Just to give you some examples of the work "behind the scenes"....

The biggest challenge has been the **Zootechnical Regulations** and their impact on PIO's in the UK (Passport Issuing Organisations). The IHSGB is a PIO and we are lucky to have Freija as our studbook expert. All PIO's have to comply with the **Minimum operating standards**, which is essentially our guidebook for compliance with the law.

DEFRA are currently in the process of checking all PIO's in the UK to ensure they are registering horses (especially cross breeds) according to Zootechnical Regulations. We are

confident that we are compliant and are looking forward to our check, so that we can start concentrating on more fun activities again.

What else has happened? **Horse Welfare** has been a much discussed subject for the past couple of years, and I would like to take one example to highlight how scientific studies (in this case conducted by the University of Zurich on behalf of FEIF) influence FEIF guidelines in a positive way.



The study subject was **Lactate recovery after speed pace tests.** Icelandic horses have (contrary to other breeds) the highest percentage of Type IIB muscle fibres (very fast twitch, anaerobic) out of the three muscle fibre types (the other two are Type I (slot twitch, aerobic) and Type IIA (fast twitch, aerobic).

In the study, 4 events were held where 37 horses were fitted with a catheter in order to measure blood lactate levels during and after the pace sprints. As expected, the lactate levels rose sharply during the sprints (highest lactate values approx. 5 mins after the sprint, starting to fall after 10 mins, and sharply after approx. 20 minutes. Walking the horses after a sprint resulted in a speedier recovering.

The results of the study were used to update guidelines for sport competition planning, leaving adequate recovery time between pace sprints, aiding horse welfare based on scientific results.

Blood mares is another topic that has concerned FEIF and most of its affiliated countries. We will be issuing a letter.

Fast forwarding to **DNA** analysis, it is possible to check your horse's DNA for the pace gene. Due to royalty fees payable in European countries, the price for DNA analysis for the pace gene is currently approx. half price in the USA. It is however understood from the genetic analyst community that they are close to offering normal DNA analysis including colour and pace gene information in one simple test in the near future.

WorldFengur, the fantastic database that links all Icelandic horses to their roots, is being updated as I am writing this summary. Colour codes of horses were updated to offer even more and precise ways of identifying horses, however our challenge was to get WF to modify the colour names to match the colour descriptions in the CED. Thanks to Freija's persistence, this challenge was eventually overcome.





Finally, the UK and EU are negotiating a **Sanitary and Phytosanitary (SPS) Agreement** to reduce trade barriers for food, animal, and plant products by eliminating routine border checks, customs documentation, and export health certificates. This will be very good news for anyone who thinks of im- or exporting horses, and it will hopefully come into place latest by 2027.

For now, I am looking forward to reverting to our normal breeding group activities straight after our DEFRA visit.



REPORT OF THE SPORT GROUP



Tölt Online

This is a long established and useful online initiative. It is available to any rider, IHSGB member or non-member, who has the possibility of riding an Icelandic horse, whether it be their own, or one that is borrowed. All competition tests are offered, and clear explanations can be found on the IHSGB website about what has to be shown in each test. Riders can enter privately for training purposes, or competitively in one of the Leagues that runs from time to time.

An Autumn and Spring League was run in 2024-2025 creating availability to compete, get marks and feedback from qualified judges. Riders can set up an area in a field, use an all-weather arena, or travel to an oval track to compete, meaning this really is available to anyone in the UK.

The Autumn and Spring League also gives IHSGB judges a good CPD opportunity.

Sport Squad A, B & C

- Elite squad (A) is made up of 4 riders
- Performance Squad (B) has 16 riders
- Grassroots Sport Squad (C) has 19 invited riders

The squads have been established in order to support our riders and to promote sport riding in the UK. In order to grow and develop our sport riding in Britain, we have embarked on creating a three tier squad system to encourage development and some new approaches amongst some riders who we identify as being either already on the path to international sport or those that we believe need assistance to be able to do so. But, it's not only aimed at top level, we would like also to develop more riders to climb the National rankings and aim to progress through from C sport to A! Some training events have been held during the year with professional instructors and judges, and riders are encouraged to support and to help each other.



British Championships and Summer Show 2025

The British Championships and Summer Show was held at Aston Le walls in June. We had quite a good turnout of members, with and without horses. Not only is it a competitive event, it is also lovely social weekend. There were classes at all levels on the Oval Track, Pace Track, Dressage arena and on the trail. It was also the last chance to gain a qualifying mark for the British Team sent to the World Championships in Switzerland in August

Regional events

A one-day sport competition was held in the spring at Connegar Farm. We are very grateful to Mike and Elizabeth Adams for offering to host this event.

Scottish Open August

The Event retained its ethos of fun with the opportunity for riders to compete and develop with their horses. An incredible collective effort had gone into organising the event and many people had given their time and expertise to make it work smoothly, some travelling long distances – volunteers from England and Wales, and all around Scotland supported the event and there was a youth contingent from Shetland.

World Championships for Icelandic Horses 2025

Six riders qualified to attend the **World Championships for Icelandic Horses 2025** in Switzerland in August. Unfortunately, due to a variety of unfortunate circumstances, only one rider was able to travel to Switzerland with her horse. She rode some good tests and we were proud of her achievements.

FEIF Conference 2025

As IHSGB Sport Trustee Fi Pugh attended the FEIF National Sport Leaders' meeting at the FEIF Conference in Vienna at the beginning of February. It's an invaluable opportunity to connect with the international Icelandic horse community and bring

back fresh ideas and inspiration. It is also important to participate in order to safeguard horse and rider welfare in the sport.

FINANCE REPORT

The 2024/25 Financial Year ended with the Society making a surplus of £1.5k meaning our balance sheet increases by the



same amount - the Society is worth £1.5k more than it was this time last year.

So, once again, how did we get there, what were the key variables and points of note and what does this mean for the future?

When setting our budget this year we planned to make a loss to reduce our reserves but, with £1.9k coming in through sponsorships and donations, thank you, our coffers remained in the black.

To help defray costs for members grants remain available to help with the expense of Member hosted events. Interest earned by The IHSGB Development Fund is used to award these grants - targeted at events and/or training that will further the Society's objectives. There is an application form on the website or email office@ihsgb.co.uk

As well as the smaller grants on offer the IHSGB was delighted to support the Scottish Open Show (their 4th!) again with a grant of £500. Help with costs were offered to those attending MEM and for our emerging Sports Squads' development.

Of course, every time you participate in the IHSGB lottery the Society also benefits. The lottery income was £400 this year...with just a handful of players. If you are tempted to gamble for a good cause then please join the IHSGB Lottery! © The payouts aren't huge but there's always the expectation they might be! Thank you.

Gift Aid, which we can claim on your membership subscriptions, also gives us an additional income stream, an estimated £1.5k this year, thank you to all those that have signed up.

Our Trustees continued to source and deliver a series of webinars offered free of charge to all members. Our Breeding Leader also organised Breeding assessments this year and has plans for another Breeding Show and fun sports show in 2025/26.

Our income streams from Members' subscriptions remained relatively steady but, in 2024/25, we lost a few more members than we gained and our income from memberships was £500 down on the previous year. The Board also decided to re-



introduce the tapered membership fee for new members joining part year – which has a knock on effect on income if not enough new members step forward.

The Society's commitment to FEIF continued and we sent two delegates to conference in 2025 plus our own International Sport Judge Fi Pugh attended with both an IHSGB and a FEIF hat on.

Of note:

- We received £1.9k of donations & sponsorships in year
- Membership Subscriptions totalled £8,799 (£9,302 in 2023/4).
- An estimated claim for Gift Aid claim brought in £1,500 from HMRC.
- We donated £500 to the Scottish Open.
- The British Championships made a £600 surplus this year (helped by another generous donation)
- Studbook activities made a surplus of £822
- Our investments are held with CAF (the Charities Aid Foundation) and with Lloyds. We received interest totalling £1,091 and a gain in fund value of £211.
- Education ran two subsidised courses with 10 participants on each, the approximate subsidy paid by the Society was £100 per participant.
- The IHSGB Lottery made a net £380.
- Two IHSGB subsidised leisure camps took place during the financial year (September 2024 and May 2025) with over 45 riders booking in! £1,400 of the £1,800 subsidy was funded by donations.

As always thank you to the members who have paid their 2025/26 subscriptions – subs become due on the Ist August each year. After that our Membership Secretary, 'H', sends a series of reminders until October 3 Ist, thereafter member benefits are lost and membership lapses. We don't want to lose you but, if we have, then please let us know why and how we could have retained your membership. Chat with Martine, our Chair (chair@ihsgb.co.uk) and provide that feedback loop.

Paying your membership gets ever easier as our website allows you to complete membership forms online or renew and update your details with simple links to PayPal or reminders of alternative ways to pay. A sign up to Gift Aid form is also available online. Whilst we applaud the convenience and ease of Paypal and thank everyone for paying by whatever means, we had to pay £179 in Paypal fees in the year. This equates



to the loss of 5 membership subscriptions. If you use BACs (bank transfers) we do not lose any of that income...just saying!

The full accounts & financial report, satisfying the requirements of our two separate Charity Commissions and those of Companies House and signed off by your Trustees and our Independent Examiner, Bevan Buckland, is available on the IHSGB website to download or by email to office@ihsgb.co.uk. Hard copy can also be posted out on request.

A reminder now about our financial standing: we know that activity throughout the Society stalled during Covid and our reserves built up. Whilst holding investments and reserves gives the Society some year on year flexibility there needs to be a robust argument to support this instead of spending such monies on the charitable cause.

Trying to reduce these reserves does give us some financial freedoms to do more but it is not sustainable longer term. Yes we still hold monies in our bank accounts and yes we want members to get the benefit of these savings but, when we look at setting budgets for the coming years, our income from members' annual subscriptions falls far short of even modest shopping lists for what we'd like to do. Once we have spent our reserves then there will need to be a significant rise in income one way or another.

Our subscription rates have not increased since 2011; budgetary pressures are real and what we would like to do to celebrate our 40th year makes significant inroads into our reserves. With a wide geographical dispersion and relatively few Icelandic horses across the country (1049) there are always going to be significant challenges for the Society to deliver on Members' expectations. Subscriptions will need to rise. To keep up with the cost of inflation alone since 2011, using the Bank of England's inflation calculator, the cost of a single membership would (should?) be £53.70 as at September 2025.



Any future Board will continue to assess the level of reserves we hold and, when they are depleted and cannot be used to boost in-year spending, a decision will be made on subscription rates. But for our 40th Anniversary year 2026 we will ensure that the Education initiative continues and that

EDUCATION REPORT

IHSGB Education Hub

Education has been able to offer two IHSGB Training courses this year;



The first IHSGB Education course was held in Scotland at Netherton Equestrian Centre in April 2025 with Sandy Carson who is a FEIF level 3 trainer educated at Holar and who is currently based in Finland. All participants really enjoyed the weekend, and the new N Scottish and Highlands Regional Co-ordinators reported "This year we had a successful clinic with Sandy Carson and would love to have him back"!



Baldvin Ari Gudlaugsson is a well-known breeder and horse trainer from Iceland and has previously been successful in Iceland competing. Baddi was in Dorset in May/June 2025 by kind invitation of Connegar Farm. The course was a success, both in riding



development and the participants also had great fun - "I have lots to learn but thank you to everyone for your friendship".

We are happy that these events are supported and enjoyed, and that we could offer education in new and different areas of the UK. In the next year, we aim to organise 2 or 3 more courses nationwide but focusing in the first instance on the Midlands or Central UK so that all areas have had access to Education. We are always looking into different trainers and venues, so we hope to find some good locations for 2026 - It is so important for our breed that riders get the opportunity to develop their knowledge and skills riding their gaited horses.



IHSGB Tolt Online

IHSGB Tolt Online continues to be a rather under utilised tool for IHSGB members (and non- members), however the Sport group have used TOL for various initiatives in the past year. Being online, it means that riders of all abilities can ride a test of their choice and receive feedback and a score from an internationally qualified Icelandic Horse judge and trainer on their gaits, it is not just about riding tests even though it is interchangeable!




We hope that this platform continues to help riders train themselves and their horses wherever they are based, and we are planning on an upgrade to the system to make it more streamlined in the future!




